CIRCULAR

Representations/options have been called from the employees in Schedule-E or F through the Circular No.01-07/Convenor-AC/6363 dtd. 28.12.2010 issued in accordance with the Energy Department Govt. of MP Order No.8460/FRS-17-XIII –2002 dtd.30.11.2010 published in extra ordinary Gazette of MP dated 30.11.2010. The last date for submission of representation/option, initially decided as 15.01.2011 was subsequently extended till 29.01.2011.

Subsequently, in compliance of the order dtd. 27.01.2011 passed by the Hon'ble High Court of MP, Jabalpur in WP No.1558/2011, the last date for submission of representations/options was extended till further orders.

Hon'ble High Court, Jabalpur vide order dtd. 05.04.2011 has modified its earlier order dtd. 27.01.2011 to the extent that the personnel of Madhya Pradesh State Electricity Board would now tender their representation/option within a period of 45 days from today.

In compliance to the aforesaid order dtd. 05.04.2011 of Hon'ble High Court of MP, Jabalpur, the last date for submission of representation/option in Schedule-E or F, as the case may be, is extended till 23rd of May 2011.

CIRCULAR

Bharat Sanchar Nigam Limited have launched an innovative scheme for all its fixed line subscribers which is known as "**Lo Karlo Lo Baat**", wherein the land line subscribers can join the scheme by paying only Rs. 149/-. This scheme provides free and unlimited calls in M.P., if the calls are made to any BSNL connections, whether it is a Landline, Mobile or Tarang .

This is very beneficial to Board/Company as most of land line connections are from BSNL. This will also keep the telephone bill within the limit as per Board's Order No. 01-01/III/I-(b)-35-(C)/977 dtd 25.11.92 read with order No.01-01/III/Tel;/Ceiling/730 dtd 16.10.93 and order No. 01-01/III/Tel/Ceiling/722 Jabalpur, dated 26.11.1994 vide which monthly ceiling of expenditure of telephone bills of different ranks of officers has been prescribed by the Board/Company.

In view of above, it is decided that, all Regional Heads as well as all SEs will ensure to avail the scheme launched by BSNL i.e. "**Lo Kar Lo Baat**" coupled with existing standard plan given under:-

In addition to above the residential fixed BSNL land line provided/availed at the residence of officers up to the rank of SE are permitted to use Plan Rs. 180 plus Pan "**Lo Kar Lo Batt**" Rs. 149. or any lower plan which is available in the telephone exchange having the same facility.

The Officers of the rank of ACE and above can choose Plan Rs. 250 plus Plan "**Lo Kar Lo Batt**" Rs.149. All those offices and residence of officer which are provided with STD facility are directed to avail the facility of **One India Plan** also in addition to above.

The present upper monthly ceiling on Telephone Bills fixed for different rank of officers has prescribed by the Board / Company and procedure for approval of over and above ceiling fixed shall remain as per present practice but each case will have to be supported by details of phone calls made with reasons.

All the Controlling Officers of fixed landline BSNL telephones shall ensure enrolment with BSNL to avail the facility under the above plan by 10th Sept.2007 positively.

The matter regarding providing communication facility to the AE(T&D)/AE(TBPS)/JE(T&D) of the company who are either in charge of Sub-Division/Zone/Distribution Centre has been reviewed and it is decided to sanction and reimburse the monthly mobile phone charges as under:-

Sr.No.	Cadre	Monthly ceiling limit
1	AE/AE(TBPS)/JE	Rs. 400.00

- 1 The mobile instrument shall be arranged by the concerning officer at his own cost.
- 2 The SIM cost / activation charges shall be borne by the concerned officer.
- 3 The concerned officer is advised to inform the mobile telephone number to this office and all concern.
- 4 Officers posted in Region/Circle/Division Office shall not be entitled for such facilities.
- 5 The Mobile connection shall be of BSNL service provider only.
- 6 All the officers/officials are advised to avail the facility of "one free land line and one free mobile number" which is being used extensively for official purposes.
- 7 Mobile facility already sanctioned vide specific orders shall continue to the officers/officials as per present practice.

The sanction of the reimbursement of monthly mobile charges as stated above shall be effective automatically from the date of joining of duty and will cease on date of relieving at a place.

The date of implementation of this order shall be from the date of issue of this order.
